## Member updates

### British Columbia

#### Michelle Young, Georgia Strait Alliance

- Canada just established a \$6.58 million Abandoned Boats Program to clean up existing small abandoned vessels across the country. It also includes outreach activities. Further funding is expected to be announced soon to address larger ships.
- BC just had a provincial election and there has been a big change in government.
- Up to 23 marinas are now certified.
- The Clean Marina program is being digitized for streamlining purposes. Beta-testing should occur within a few months (e.g. getting marinas to test the process). It is not publicly accessible it is for marinas to perform self-assessments of environmental best

practices. Currently it is done via a Word document and eventually it will incorporate updates from the handbook.

#### California

#### Vivian Matuk – CA State Parks and California Coastal Commission

- Dockwalker Program. So far this year, staff has conducted 10 Dockwalker trainings around the state, with a total of 150 attendees.
- Staff has participated in two boat shows. At the shows, staff has shared clean boating information with over where 500 boaters and distributed over 400 boater kits.
- Fuel Dock Project. Staff is currently working with CA OSPR on a new educational project
  for fuel docks. The goal is to create educational tools for fuel dock operators that will
  help them implement BMPs to avoid pollution, learn how to report spills, etc. Staff and
  partners will be surveying fuel docks to identify the types of education tools that are
  most suitable.
- The <u>Spring Changing Tide Newsletter issue</u>. The Boating Clean and Green Program (BC&GP), with its partners The Bay Foundation and The Keep the Delta Clean Program released the 2017 Winter issue of the Changing Tide.
- Marina and Yacht Clubs Oils Spill Response Communication Workshop. BC&GP staff in partnership with OSPR and the California Office of Emergency Services (CalOES) conducted a workshop on March 30 at the Dockweiler Youth Center in Marina Del Rey. The seminar covered oil spill response resource information.

#### Steve Gonzales - CA OSPR

- His team came up with talking points for use with the press in the event of an oil spill. If there was a spill of anywhere between one and 1,000,000 gallons, these talking points would work.
- CA's Oiled Wildlife Care network has media response guidelines that easily fit in your pocket. It includes simple things like how to prepare talking points, be polite, etc.

#### Washington

#### Franji Mayes – WA Dept. of Ecology

- There are 11 new geographic response plans in WA half are in the eastern side of the state. This is due to the increased need for planning due to increases in transport of oil by rail.
- She recently attended a media training for Ecology responders in Wenatchee. They had a boat operation training and she got to see how they train, as well as assist Sandy Howard, the Spills Program communication manager, with media interaction training.

- Ecology issued a penalty on a grounded vessel from a year ago press release went out. http://www.ecy.wa.gov/news/2017/047.html
- A year ago, there was a fatigue-related grounding situation in WA that resulted in penalties. The boat's captain agreed to do a video interview. Ecology is in the process of making an anti-fatigue video out of it. She'd like to share the draft (if ready) at the next POSPET meeting.

#### **Andy Gregory – Puget Soundkeeper Alliance**

- There are currently 73 certified clean marinas in WA (no substantive change from the last report).
- PSA received a new round of funding that went live at beginning of April. His program has been on hold over the winter because of the funding gap. Their traditional funding source is WA State Public Participation grants. The new funding is a \$100K grant over two years to roll out the recently adopted No Discharge Zone, including a PSA that will focus on sewage pump out usage/spill prevention. The grant constrains clean marina work to the Puget Sound basin. He's working with Aaron Barnett at Washington Sea Grant Aaron will take the lead on Clean Marina certifications in non-Puget Sound regions.
- There are great things happening in WA. He is working to put together a service in the San Juan Islands re: pump out ability and will work with Aaron on it. This could be something good to share at a future POSPET meeting.

## Agreed to/next steps:

- Members agreed to increase the number of meetings per year from three three-hour meetings to four two-hour meetings. Meetings will be held quarterly. We will keep the October 2017 meeting and reduce it to two hours and will add a mid-summer call.
  - Steve G will look into possibility of Skype Business as an option so that we can connect via video.
  - o Andy suggested possibility of incorporating more guests as topic allows.
